## 2025 Rules and Regulations

**QUIET HOURS:** 11PM to 8AM. Voices, Televisions, Radios, Phone Calls, etc... must be kept at a low volume during quiet hours. Please respect your fellow glampers who wish to get a good night's sleep free from loud and disturbing noises.

**SPEED LIMIT:** 10 MPH. This is slower than you think so PLEASE ensure you are abiding by our speed limit - PROTECT OUR CHILDREN.

**CLOSED AREAS:** Glampers and guests shall not enter closed areas such as event venues or other glamping sites without permission.

**VALUABLES:** Please keep your valuables (e.g. wallet, cellphone, keys) with you at all times. The glamping site is not liable for any lost valuables.

**FOOD:** Please ensure that you dispose of any food leftovers, as these can attract wild animals such as coyotes, wolves, bears, and raccoons.

**ROCK CLIMBING:** There is a cliff that overlooks the Glamping site. Rock climbing or any related activities on this cliff are strictly prohibited. WE ARE NOT RESPONSIBLE FOR ANY DAMAGES AND/OR INJURIES IF THIS RULE IS VIOLATED.

**WILDLIFE:** For your safety and those around you, please keep a safe distance from any wildlife when observing them. HARASSING AND/OR HUNTING THE SURROUNDING WILDLIFE IS STRICTLY PROHIBITED.

**STAFF:** Our staff must be treated with both respect and dignity. They are here to make your glamping experience both easier and more enjoyable. Those who mistreat our staff will be removed from the glamping site without reimbursement.

**WEAPONS:** Weapons are strictly prohibited on the Glamping Site and its property. Law enforcement officers are excluded from this policy.

**CHILDREN'S CONDUCT:** Parents are responsible for their Children's conduct and will be held liable for any damages they cause. BULLIES WILL NOT BE TOLERATED and will be permanently banned from the Glamping Site! CHILDREN WHO CAUSE DISTURBANCES BETWEEN 11PM & 8AM ARE SUBJECT TO A PERMANENT CURFEW DURING THESE HOURS.

**VEHICLES:** Motorized vehicles operated on the site must be legally licensed, registered, and insured. When driving, all vehicles must obey the posted speed limit. Operators must possess a valid driver's license. Repairing vehicles, including oil changes, are strictly prohibited on the site.

**WASHING CARS:** Washing cars or trucks on the Glamping Site is prohibited. There is an automated car wash located 3 miles away.

**BICYCLES:** Bicycles are permitted on the site. Please be aware that Pennsylvania law requires that children under 12 wear a helmet. Children under the age of 18 must be accompanied by an adult whenever riding. We strongly advise that those who ride stay in the site, since the highway outside the site is very busy.

**SMOKING:** Smoking is only permitted in designated smoking areas throughout the site. Smoking inside of a tent or other accommodation is strictly prohibited. Please respect this rule, since the threat of wildfires in Pennsylvania is high, and one ember from a cigarette could ignite a large fire. Whenever extinguishing cigarettes, please ensure that it is fully extinguished before throwing it out.

**PET POLICY:** Pets are welcome on the glamping site! To see our policy regarding pets on the site, please view our pet policy document.

**EVENT HOSTING:** Our site welcomes those who want to host events. Those who host events must ensure that they obtain valid event insurance, which must be presented to glamping site management in advance.

**LIABILITY:** Copacabana Glamping is NOT RESPONSIBLE for damages caused by fire, water, or collisions, loss caused from theft, mischief, or misuse of equipment to any personal property, or personal injury. Management reserves the right to refuse service to anyone who does not comply with these rules.
